Re: Brisbane Olympic and Paralympic Games Arrangements Amendment Bill 2024

The Queensland Tourism Industry Council (QTIC) welcomes the opportunity to provide feedback to the Housing, Big Build and Manufacturing Committee regarding consultation on the Brisbane Olympic and Paralympic Games Arrangements Amendment Bill 2024 (the Bill).

QTIC is the peak industry body and leading advocate for the tourism, hospitality, and events sectors in Queensland, committed to the growth and sustainability of the state visitor economy. Our efforts focus on powerful lobbying, policy development, and collaboration with key industry stakeholders to create a favourable business environment for operators. As a not-for-profit, membership-based organisation, we take pride in ensuring that the concerns and needs of our members and the broader tourism industry inform all relevant policy debates and that businesses have strong representation in decision-making processes. By promoting the value and importance of tourism in government forums and to the wider community, we help to create a vibrant, diverse industry that benefits all.

Tourism is a dynamic, multifaceted industry, comprised of passionate people showcasing Queensland's unique destinations, rich cultural history, and experiences. This industry fosters strong community ties through diverse services and business opportunities, while a dedication to research and innovation continually opens new avenues for growth and development in the state. Tourism stimulates growth in sectors including agriculture, construction, manufacturing, transport, retail, education, and training, circulating an additional 86 cents in the economy for every dollar spent (2022-23). The industry is also relevant to many, if not all, government portfolios and involves all three levels of government, contributing \$1.5 billion in net taxes to federal, state, and local revenue.²

In December 2023, tourism generated \$34 billion in Overnight Visitor Expenditure (OVE)³ and accounted for 6.3% of total state GSP (direct/indirect), ranking as Queensland's fifth largest export.4 The Queensland tourism industry represents 68.4% of total state employment, comprising 260,000 jobs (direct/indirect)⁵, and is projected to have the third fastest employment growth by 2025-26.⁶ However, the industry faces significant ongoing workforce shortages, with 4,147 job vacancies across the state.7

- We endorse the establishment of the Games Venue and Legacy Delivery Authority and its board.
- QTIC is currently working with the Queensland Government Department of Tourism and Sport
 to facilitate implementation of the *Towards Tourism 2032: Transforming Queensland's visitor*economy strategy (TT2032). This involves consulting with industry through coordination of
 various reference groups, comprised of industry sector associations, regional and local
 destination management organisations, and tourism operators from across the state.
- We highlight specific recent QTIC submissions which can offer insight into key tourism industry priorities for Queensland and serve as foundational resources for the Authority:
 - o 2023 <u>submission</u> to the Treasury regarding the *2024-25 Queensland Budget*.
 - 2023 <u>submission</u> to the Department of State Development, Infrastructure, Local Government and Planning regarding the *Brisbane 2032 Olympic and Paralympic Games Legacy Plan*.
